*Cooperation agreement between Institute of Humanities and Cultural studies  
(IHCS) and Al-Farabi University*

***Introduction:***

*In the context of the necessity to develop scientific cooperation between Institute of Humanities and Cultural studies (IHCS) from one hand and Al-Farabi University of Kazakhstan from the other, in the field of scientific, cultural and research relations about the development of Iran and Kazakh Studies, both institutes acknowledge mutual benefits which result from cooperation in joint scientific projects and programs.*

***Part one) the contents of the agreement:***

- 1. Cooperation in the field of Persian literature, philosophy and humanities, linguistics, history and archeology of both countries*
- 2. Professor deployment based on the requirements in the related fields*
- 3. Exchanging annually one PhD student and two MA students by the Institute of Humanities and Al-Farabi University*
- 4. Participation in holding lectures, conferences, scientific meetings and other international or national scientific activities by mutual agreements*



5. Exchange of scientific information and providing easy access to scientific literature, including books, journals, and other scientific documents

6. Cooperation in planning, writing and translation of Iranian and Kazakh Studies by two parties' suggestions

7. Cooperation in the field of publishing books, periodicals and scientific journals besides annually publication of joint Iran-Eurasian Studies

8. Starting Kazakh studies program in the Central Asia Room

9. Other academic cooperation based on the two institutes' agreement

**Part two) Procedure:**

10. To achieve the above-mentioned cooperation, the parties undertake to determine their fully authorized representatives immediately after completing the agreement signatures to implement its parts. Representatives also required to continuously inform related parties of their activities and outcomes

11. The parties may, for each of these areas and specific topics that are under the contract of the two institutions, sign and exchange separate contractual arrangement.

12. Administrative and financial obligations of each of the two parties' on issues and programs of cooperation will follow in two centers according to the agreements in executive committees and approval of the relevant authorities

13. Any dispute or unforeseen issues in the implementation of the agreements will be negotiated by the parties

**Part three: Time of implementation of the agreement**

14. This agreement will be implemented after signature by the parties and will have the ability to run up for five years. This period will be extended automatically unless the contrary is agreed. Request for unextending must be submitted in writing at least six months ago. In the case of non-renewal of course, unfinished obligations of both parties should be fulfilled.



15. The same agreement may be modified or terminated by written request of the parties. The request must be in written form and at least six months before the beginning of the amendment or termination should be provided.

**Part 4: Conclusions**

16. It is hereby certified that the present agreements provided in four chapters, 16 articles and three copies of the authentic form and signed by authorized representatives of both sides. This agreement is applicable from the date of the signatures of the parties.
